## AUDIT RESULTS

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

### About the audit

This report contains the results of our independent accountability audit of the Whatcom Transportation Authority from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – general disbursements and electronic funds transfers
- Tracking and monitoring of theft sensitive assets, such as computers, tools, and equipment

## INFORMATION ABOUT THE AUTHORITY

The Whatcom Transportation Authority, created in 1983, serves approximately 225,000 Whatcom County residents. The Authority provides fixed route and vanpool services, as well as transportation services for the elderly and disabled.

A nine-member Board of Directors governs the Authority which is comprised of elected officials from Whatcom County jurisdictions that benefit from the Authority. The Authority has approximately 275 employees and operating expenses of approximately \$36.6 million for fiscal year 2019 and \$34.2 million for fiscal year 2018.
